After registration, British Council will check your level and accordingly you will be eligible to join the specific level. The Mobile App based English Score test will be conducted from 19th to 23rd March, 2026 (according to your convenience)

The salient features of the courses are as below:-

1. Course Fees is Rs. 14,672/- (including 18% GST of Rs. 2238/-)
2. Course Duration is 18 weeks with 18 weeks access, with a total of 108 hours expected study time **from 25th March, 2026 to 29th July, 2026**.
3. Each week you will complete 3 hours online exercises before your class, attend a 55 minute live online class at a timing of your choice, attend one Live25 teacher-led webinar of your choice and learn on post class study material.
4. Please note you need to complete this each week, the class and assignments cannot be postponed or taken later. The classes are available 24/7, 7 days a week to book at your own your choice. You can cancel a class 24 hours in advance and rebook the same class in that week. The cancelled class cannot be carried over to the next week.
5. Infrastructure requirements: To access the student portal and attend the live online classes, you will need a desktop/laptop computer (preferred) or a mobile device (tablet, smartphone), a reliable Internet connection, a headset or headphones with a built-in microphone and a working webcam.
6. **Pre Online assessment test will be conducted by British Council for the registered candidates from 19th March to 23rd March, 2026 (fees for assessment is already included in the course fees).**

7. **Online Certificate can be downloaded by the learner from English Online Learning Platform of British Council after successful completion of the course provided the learner completes 67% of the assignment and attends 4 out of 6 classes per module of 6 weeks each.**
8. Only ICAI Members and Students are eligible to enrol in the said course.
